- 2. The candidate should note that his/her name will be entered on ballot forms exactly as it shows on the nomination form.
- 3. Each candidate for election may provide in writing to the Trust office, a profile in not more than 200 words, details of his/her ability, experience and knowledge relevant to the position of trustee.
- 4. A candidate may at any time before the closing time for nominations, withdraw his/her nomination by writing to the Trust Office.
- 5. All beneficiaries are urged to contact the office to notify the Trust of your current postal address or any change of address.
