1. If the number of nominations total 8 or more an election will be held by postal ballot. The election date will be 4 November 2019. Ballot papers will be distributed by post one month before the election date and must be returned to the Returning Officer by the election date.

3. Each candidate for election may provide in writing to the Trust office, a profile in not more than 200 words, details of his/her ability, experience and knowledge relevant to the position of trustee.
4. A candidate may at any time before the closing time for nominations, withdraw his/her nomination by writing to the Trust Office.
